

Socially Responsible Public Procurement of ICT

- Develop and share tailored procurement approaches for socially responsible ICT procurement, including technical specifications, award criteria and contract performance clauses.
- Explore opportunities to <u>engage with suppliers</u> in order to send stronger signals of demand for socially responsible ICT products and services.
- Collaborate on <u>verification methods</u>, such as monitoring and evaluating mechanisms, for ensuring suppliers are meeting socially responsible contractual obligations.


